Dear Parents,

Interschool Sport Gala Days for students in Years 4, 5 and 6 this term will be held on:

- Friday 26 May;
- Friday 2 June;
- Friday 9 June.

Each Gala Day, students will need to:

- Be at school no later than 8:30am (bus leaves at 9:00am);
- Wear their full school uniform (not house shirts);
- Bring a water bottle and packed lunch (there is no guarantee students will be able to buy food at the venues).

Soccer players will need to wear shin pads and long navy blue socks (socks can be purchased at the uniform shop).

Venues for the Gala Days will be:

- Netball at Downey Park, Cnr Northey St & Green Tce, Windsor;
- Soccer at Brisbane Boys Grammar playing fields, Northgate;
- Tag League at Norths Rugby League, Shaw Road, Woolloowin.

Students will be required to pay \$7.00 per Gala day or one payment of \$20.00 for the three Gala days, for transport to and from the venues. We would like to thank the P&C for subsidising the bus fares for students. Please ensure students pay for transport in advance, rather than turn up on the day with money for transport. **Students must pay for transport to take part in the Gala Sports Days.** Attendance at Sports Gala Days will depend on the ability of a student to manage their own behaviour.
